1. Call Meeting to Order

Meeting was called to order by LION Chair Brett Budrow at 4:47 PM.

2. Approve Agenda

- 4. Introduction of New LIOs We welcome Aaron Brault from Sheboygan County, Al Murray from Forest County, and Donna Liebergen from Florence County.
- **5.** Appointment to the Wisconsin Spatial Reference System Task Force Asked to have someone on the Legislative Focus Group. Eric Damkot will serve on this task force.

6. Election of Officers

Chair-Elect: Zach Newton LIO-at-Large: Joe Martell

All candidates were approved by unanimous voice vote.

7. Legislative Technology Services Bureau Update (LTSB)

Tony Van Der Wielen reported that the January Boundary and Annexation Survey (BAS) data collection was in on time for all 72 counties. However about 30 counties need to click "finish". All data has been published out to the public data page. Zach is working on taking the data submitted in January and submitting it to the Census Bureau. This is your final push to get data to the Census Bureau.

Some people received a letter for PSAP Boundaries. It is an optional participation. If you have any questions, please let Tony know.

Tony sent out an email about BAS information to the County Clerks. They need to get the Highest Elected Officials name submitted. Any assistance from the LIO in this matter would be a great benefit.

Numerous Counties participated in the LUCA. So far no one has received any information back.

There will be a full pilot of Redistricting next year. LTSB is looking for Counties who can start it and finalize the application at the end of the pilot. Please let him know if your county is interested.

8. Department of Administration (DOA)

Peter Herried reported that V5 call for data is out there and due by March 31st. He encourages the Counties to read the full documentation you received from the DOA. Land Information Plans – Thank you for your updates. This time around it was good quality and the information is very helpful.

2019 Grant – Base budget grants should be coming in the next couple of weeks. The sooner your submittal, the sooner you will receive your grant.

2020 Grant applications should be out by October 1st. Max grant amount should be around \$40,000.

9. State Agency Geospatial Information Committee (SAGIC)

Colter Sikora from PSC reported that SAGIC will have their input on a technical standards document by March.

There is an ongoing project called "Maps Matter"

Chasing Data Project - Hoping to get data advertised.

10. Wisconsin Land Information Council (WLIC)

Kelly Felton reported that The GIO brought up the 3-DEP program in 2015. The plan is to complete the whole program by 2023. WLIC will have input on this project. The GIO also mentioned a 3_D Nation study that has done it 12 years ago and are looking to do it again. The GIO will be looking for information.

11. Street Centerline and Address Point Data Standards

Fred Iausly and Eric Damkot explained that they are considering seeking formal endorsements of the standard. Eric stated that the WLIC had a lengthy discussion regarding it today and Fred stated the LTSB has been working with the Standards Committee and that Tony is looking at tools for evaluating our data. We are now looking for an establishment of a Standard and will then look at implementation, Motion: LION formally endorse the Standard. Motion made by Jeremiah Erickson and 2nd by Brett Budrow. Motion passed.

12. Any other business

Jeremiah Erickson stated that in the Wheeler Report there was mention of a Legislative Reference Bureau #1665 – relating to property tax assessments regarding leased property and assessments base on comparable sales and market segments. If this would pass, it will become effective January 2020. There is also a Senate Bill 13 relating to notification of changed property tax assessment for agricultural land.
