#### 1. Call to Order

Al Brokmeier, LION Chair called the meeting to order at 4:38 P.M.

#### 2. Agenda

Fred Iausly moved to approve the agenda for Thursday, February 19, 2015; seconded by Kelly Felton. Motion carried unanimously, agenda approved.

#### 3. Minutes

Sara McCurdy moved to approve the minutes from the October 9, 2014 meeting at the Heidel House, Green Lake, WI; seconded by Doug Avoles. Motion carried unanimously, minutes approved.

**4. DOA Report: Biennial budget review – GIO status – Funding Appropriation update** Mike Friis reported that the WLIP budget is raised in the Governor's proposal to match the expected increase in income due to sunset of \$5 redaction fee.

Mike also reported that DOA is moving ahead with the GIO position. An exam was administered to applicants. Those who scored high enough will be interviewed.

#### 5. Land Information Plan

Peter Herreid reported that he emailed the Land Information Plan Time table at the end of December (included below).

The instruction writing work group includes LIOs. Land information councils must review and approve new plans. Plans will be required on a 3 year cycle beginning in 2017. Al asked if there will be funding available for the \$50,000 grants. Peter responded yes, and the 2016 grant applications will be out in October. Al pointed out that all spending must be in agreement with current plans.

# 6. County-wide Assessing

Russ Schwandt, President WAAO, reported that the proposal for county assessing was unknown to the assessing community and didn't come from them. The goal of the proposal is unknown as well, perhaps an effort to shrink the Department of Revenue, stated purpose is improved uniformity and fairness. Two things we do know are that no county has an assessment office and

the funding proposal for annual reassessment is inadequate. Asked if the WAAO could fix the assessment problems Russ responded that poor oversight has led to the problems.

#### 7. V-1 Project Update

Howard Veregin reported that the project began in 2014 as an extension of the Link Wisconsin broadband project. The V-1 project received \$120,000 from DOA for staff. All 72 counties submitted parcel data for the project. Next steps include addressing missing attributes required by Act 20 and conversing with DOR on the assessment data already being submitted.

#### 8. State-wide monumentation initiative

Brenda Hemstead reported on an initiative to develop survey grade coordinates on Public Land Survey System monuments along county boundaries. There will be a forum March 12 at UW-Stevens Point to help develop a business case for funding.

#### 9. Geospatial Strategy Workgroup

Justin Connor stated that there is an as hoc group discussing an advisory council for the GIO. Justin explained that this is an ad hoc group for everyone and is not part of any existing group or process. Membership in the advisory council has not being defined yet. Don Dittmar voiced concern over duplication of effort and wondered if there was a list of geospatial groups. Don wonders why there are so many. Tony Van Der Weilen noted that SAGIC is deferring to WIGICC on strategy.

# 10. UW-Library System data acquisition

Jaime Stoltenberg reported that the Robinson Map Library has been archiving data since 2005. The archive is currently only available to students at Madison, Milwaukee and Eau Claire. A recent survey of LIOs showed 86% are willing to share data with entire UW system.

# 11. SAGIC (State Agency Geographic Information Committee) report

Fred Iausly delivered an update on SAGIC activity.

#### 13. New Business

LION website is registered until April, 2017. Fred Iausly reported that Dane County, who generously hosts our website, is in the process of reconstructing the entire site.

Ed Harvey posed an informal survey about parcel mapping accuracy:

Do you test professional map accuracy(aerial photos, planimentric)? 26 of 55 county representatives respond yes.

Do you test parcel mapping accuracy? 0 of 55 respond yes

Ed asked for a best estimate of accuracy of parcel boundaries from the group:

95% within 100 feet – 36 respond yes

95% within 50 feet -- 30 respond yes

95% within 25 feet – 16 respond yes

95% within 10 feet – 8 respond yes

95% within 2 feet -0 respond yes

Sara McCurdy, LION Chair, asked to be contacted with agenda items and other concerns.

Peter Herried reminded us that the recording fee form was revised beginning January 1, 2015. Peter asked if we could remove the LIO signature requirement to remove a step for the Registers—of-Deeds. Don Dittmar responded that if we remove the LIO signature we would also need to remove the certification of proper spending. Peter will leave the LIO signature line in place until LION asks that it be removed.
